RETENTION OF SPECIAL EDUCATION RECORDS

In accordance with ARS §41-1351, the retention period is four (4) years for special education records. EDUPRIZE Schools LLC will destroy special education records of dismissed students or students withdrawn from any EDUPRIZE location for four (4) years or more from the current academic year.

Prior to the destruction of records, you have the right to review the records and obtain copies of any information. To obtain records you must be the parent or the legal guardian of the student or the student (age 18 or older). Please indicate your request by contacting the Special Education Department of the campus the student attended before December 31st.

If you do not contact the Special Education Department on or before December 31st, we will destroy all records four (4) years older than the current academic year.
